VENDOR ARM BANDS – ALL VENDORS MUST HAVE ARMBAND AND LANYARD FOR EACH PERSON WORKING IN BOOTH.

SPACE PURCHASE INCLUDES: 2 weekend vendor armbands/lanyards per 10x10, food vendors receive 3 per 10x10. Additional employee armbands/lanyards are \$10 and can be included with vendor application payment. Armbands/lanyards distributed at check in.

FOOD VENDORS:

- Gray water disposal \$35 (required for all food vendors)
- Food vendors must purchase beverages from rally, price list and delivery times will be in vendor packets at check in.

ADDITIONAL ITEMS:

- Unimproved RV Site \$35/weekend
- Donate door prizes for stage promotion of vendor booth
- Sponsorship of contest or event

- **Agreement**

The undersigned, referred to below as Vendor, submits this contract for the reservation of display space with the Four Corners Motorcycle Rally (FCMR), during the Four Corners Motorcycle Rally, subject to the conditions and regulations detailed in this document. Failure to comply with any part of this agreement will result in immediate closure of vendor's display space and forfeiture of all monies paid. Four Corners Motorcycle Rally and FCMR, LLC reserves the right to refuse service to anyone.

- **Licensing Regulations**

Ignacio Bike Week and/or Four Corners Motorcycle Rally and Logos are Trademarks licensed to Four Corners Motorcycle Rally, LLC (FCMR). Any unauthorized duplication, display, or use of the names or logos is strictly forbidden. Any vendor found with unauthorized items, signs, or merchandise displaying the Ignacio Bike Week and/or Four Corners Motorcycle Rally and/or logo will be evicted and forfeit all monies paid. All unauthorized materials will be confiscated. The FCMR, LLC reserves the right to pursue legal action in cases of trademark infringement.

- **Set Up/Tear Down/ Hours of Operation**

Vendor spaces are assigned upon receipt of PAYMENT IN FULL. All required documentation must be turned in by August 1, 2016. Vendors may NOT place stakes in any asphalt area and are required to secure canopies with adequate weights or stakes (where applicable). Set up will begin for vendors on Wednesday, August 31, 2016. Vendors are required to be set up for business by 2:00 PM on Thursday, September 1, 2016. All vendors are required to be open from 10:00 AM- 9:00 PM from Friday September 2, 2016 through Sunday, September 4, 2016; earlier/later hours are permitted. Absolutely NO tear down prior to close of event on Sunday night. Authorized tear down is Monday, September 5, 2016; vendors must have property and debris removed from premises by 6:00 PM.

- **Cancellation**

The event WILL NOT be cancelled due to weather, therefore, there will be no refunds given as a result. NO REFUNDS for any reason.

- **Additional Rules/Regulations**

Any unauthorized use of the Ignacio Bike Week and Four Corners Motorcycle Rally names and/or logos is prohibited by the law. The playing of ambient music must be confined to the Vendor rental space area. NO SUBLETTING, assignment, or subdividing of space by any Vendor shall be permitted without advance written permission of Four Corners Motorcycle Rally or FCMR, LLC. Any merchandise displaying foul language or obscenity must be approved in writing in advance of event by Four Corners Motorcycle Rally or FCMR, LLC. Sales of knives, swords or any other weapons must be approved in writing by Four Corners Motorcycle Rally or FCMR, LLC. Vendors must secure knives, swords, or any other weapons from public access. ABSOLUTELY NO FIREARM SALES WILL BE PERMITTED. There is no tent camping or RV camping near vendor spaces. Vendor may stay overnight inside rental space if they choose. All vendors will obey pertinent fire and safety codes, laws, ordinances, and regulations by the Town of Ignacio, State of Colorado, and Four Corners Motorcycle Rally. Per safety codes, all canopies must be fire retardant. Vendors are responsible for protecting themselves and/or their property against the weather. Food vendors are required to have a current Food Establishment License. Absolutely no dumping of gray water, food, or any other refuse is allowed on event premises, violators will be fined up to \$500. All food vendors are required to pay a \$35 gray water disposal fee and will be directed to the appropriate location for disposal at check in/set up. Grease disposal is not permitted at gray water disposal location! All vendors are responsible for the proper handling, storage, and disposal of grease and oil.

- **Insurance/Risk of Loss**

Neither the Four Corners Motorcycle Rally, FCMR, LLC, nor any sponsor associated with the event, their officers, directors, agents, consultants, and employees (“Releasees”) are responsible for any injury, loss or damage from or to any Vendor, its staff or property. Vendor, upon execution of this contract, expressly releases the Releasees from any and all claims for loss, damage, or injury and agrees to indemnify Releasees against such claims. To prevent lost or stolen articles, all items must be securely fastened to display boards or locked up when space is unattended. Overnight security is NOT provided and Four Corners Motorcycle Rally, FCMR, LLC, or the owners individually, shall not be held responsible for the Vendor’s merchandise. Any and all restrictions enforced by Four Corners Motorcycle Rally and FCMR, LLC must be observed by Vendor.

- **Liability**

FCMR, LLC's Liability is limited to items expressly assumed herein. In no event shall FCMR, LLC's liability exceed the amount of the rental agreed herein. UNDER NO CIRCUMSTANCES SHALL FCMR, LLC BE LIABLE FOR ANY INCIDENTAL, CONSEQUENTIAL, OR OTHER DAMAGES AND/OR EXPENSES. FCMR SHALL NOT BE SUBJECT TO ANY LIABILITY OR OBLIGATION NOT EXPRESSLY ASSUMED HEREIN, WHETHER ARISING OUT OF BREACH OF CONTRACT, WARRANTY, TORT, OR OTHER THEORIES OF LAW. VENDOR WARRANTS AND AGREES TO INDEMNIFY FCMR, LLC FROM SUCH LIABILITY AND SUCH INDEMNITY SHALL INCLUDE IDEMNIFICATION FROM CLAIMS BY VENDORS' EMPLOYEES OR AGENTS.

- **Payment**

A deposit of 50% of the total amount due is required at time application/contract is submitted. FCMR, LLC accepts money order, cash, credit card, and company checks for payment. No checks will be accepted after July 1, 2016 NO EXCEPTIONS. Please make payments out to FCMR, LLC. Deadline for payment in full is July 1, 2016. Applications sent after deadline will be subject to additional charges as listed on space rental page of contract.

- **Force Majeure**

This contract shall be governed by and construed in all respects by the laws of the State of Colorado. The parties hereto agree that the only proper venue for any cause of action arising hereunder shall be in the state courts of the State of Colorado and Vendor hereby consents to the jurisdiction of such courts. In the event that any provision of this contract is declared void or unenforceable by any competent legislative or judicial authority, said declaration shall not affect the enforceability of any other provision, it being the intent of the parties that this contract shall be severable and applied as if such void or unenforceable provision had not been included herein.
